

Blendon Township Police Renewal Levy

Vote "Yes" for Issue 5

Your Blendon Township Trustees have placed a 4-mill, 5-year renewal levy on the upcoming November 8 ballot. This renewal levy makes up 51 percent of the total Blendon Township Police Department operating budget. The current levy is set to expire at the end of 2011. Passage of this levy is crucial if we expect police services to be maintained at the present level.

With this levy renewal, real estate taxes to support

the Police Department will not increase; this levy will remain at \$122.50 per \$100,000 of property valuation.

Our police department is funded by five levies—three very small permanent/continuous levies and two 5-year levies. The total cost of all five levies combined per \$100,000 valuation per year is \$231.20. The entire cost of our police department is not solely shouldered by the residents. Commercial and industrial property owners share the same cost per \$100,000 valuation, and this equates to 27 percent of the Police budget.

Your Blendon Township Trustees are asking voters for their continued support of the Police Department with a "Yes" vote on Issue 5 on November 8.

Yet Another Rate Increase; Pending Sale of Our Water Treatment Plant

OAWC Update

On July 1, 2011, Ohio American Water Company filed an application with the Public Utilities Commission of Ohio to adjust its rates for water and wastewater service in all their Ohio operating districts. This is the first step of an approximately nine-month process to increase our rates.

The Huber Ridge water treatment plant, according to OAWC, serves 2,300 customers. OAWC states the average household usage per month is 4 ccf. (Note: Three increases ago, they stated the average was 6 ccf.) Using this average, the typical household would see an increase of \$9.02 for water, and \$5.13 for wastewater per month for a combined total monthly increase of \$14.15 using 4 ccf as the average.

The PUCO by statute has 275 days to review OAWC's request, garner public opinion, and issue an order.

Then on July 11, 2011, OAWC issued a press release stating: American Water to purchase Aqua America's New York operations and to sell all Ohio operations to Aqua Ohio.

Under the announced agreement with Aqua, American Water will purchase Aqua's seven water systems in New York for approximately \$71 million; and American Water will sell 8 water systems and 1 wastewater system in Ohio to Aqua for approximately \$121 million. Completing both transactions is subject to the approval of the public utility commissions in both New York and Ohio. The approval and sale is expected sometime in the first three months of 2012.

While the sale and purchase of these systems do affect us, they will not affect the current application for increasing our

rates. OAWC is moving forward with the application process. Since 2000 when OAWC purchased the Huber Ridge treatment plant, there have been five applications to raise rates: the first in 2003, then in 2006, 2007, 2009, and now 2011!

GRACE Fellowship Church of Westerville

Our Huber Ridge community is blessed to be surrounded by some wonderful community groups. One of these groups is GRACE Fellowship Church of Westerville located at 3475 Paris Boulevard. On the website for GRACE Fellowship, I noticed a little caption that caught my attention. It says, "GRACE—a place to call home."

I spoke with Marilyn Malcolm, the Program Director at GRACE, who shared with me about what makes GRACE so special. Its mission statement is "We exist for the glory of God and the good of the city by extending hope through the gospel of Jesus Christ."

GRACE Fellowship Church has been in Huber Ridge for many years. Previously, it was called Grace Baptist Church. It is still affiliated with the Baptist church but decided to change its name to let people know that it is open to all people and not just those who are Baptist.

As evidence that GRACE Fellowship is open to all people, due to a growing number of Russian members attending GRACE, a Russian language service was made available along with the English-speaking service. There are about 50 Russian-speaking members, who can now participate in a worship service in their own language.

One of the special programs at GRACE Fellowship is its Maternity Resource Center. This is a long-time ministry to help mothers of children from birth to age 3. The Church receives donations of baby items such as clothes, toys, and anything else that a baby needs. Any baby items can be given as a tax-deductible donation for the Center. Mothers in need can contact the Maternity Resource Center and receive help. Baby items are made available to mothers free of charge.

Other programs offered at GRACE Fellowship are ministries for Children (ages 3 to 5th grade), Student Ministries (grades 6 to 12), Men and Women Ministries; and College and Career Ministries. Service times are on Sunday at 9:00 a.m. for Sunday School and 10:15 a.m. for the Worship Service. The church also has small group ministries and *Bible* studies.

GRACE Fellowship has a big garage sale each year with all sales going back into the ministry. The Church will accept donation of items for their garage sale and will even provide a pick-up service for the donations. The next big garage sale will be on Friday, September 30, from 9:00 a.m. to 2:00 p.m. and Saturday, October 1, from 9:00 a.m. to 11:30 a.m. Mark this garage sale on your calendar and check it out because items will be sold at great prices.

Joe is the Community Relations and Safety Director for Respite Connections, Inc. It is located just across 161 from Buenos Aires Boulevard in Strawberry Farms. A non-profit social service agency, it was established in 1999.

The primary purpose of Respite Connections is the temporary care of an individual with special needs. They are fully licensed with specially trained and experienced staff. Mary Wright, CEO of Respite, together with her other

responsibilities, is fluent in American Sign Language. Four of their administrators are non-speaking. Staff members include Krystle Isaacs, Jonathan Garnett, Caitline Stiles, Lindsay Dauner, George Osei-owusu, and Lauren Mason.

Those attending Respite at the Strawberry Farms location range in age from 16 to 21 years and number approximately 27. They are able to participate in a variety of fun and educational activities: day camp, after-school program, adult-day-care services for the deaf, and a foster-care program. When necessary, they also care for infants.

A second Respite facility is located in New Albany at the Franklin Church. It serves the needs of 30 children ranging in age from 5 to 13.

At the end of May, a group of these young men and women did a wonderful job of helping to deliver the summer edition of our newsletter, *The Herald*. We profoundly thank them!

They should be very proud of themselves! While I try to GROW old gracefully, they try to GROW in learning, improving their communication skills, healing, loving, and laughing. The staff and Mr. Joe Green, who is the heart of this group, not only provide the learning tools necessary but also the care, compassion, and love for those they serve.






Thinking Ahead ...
