# Huber Ridge Area Association Minutes General Meeting 5-3-2012

**Household of the Quarter:** Joy Neff introduced Jack and Janet Brown and presented them with a certificate as the HRAA Household of the Quarter. They also received a certificate for one half off of their yearly membership dues.

**Approval of minutes:** Motion was made by Eric Cordray and the motion was seconded to approve the minutes of the April 5th meeting. **Motion carried.** 

#### **Unfinished business:**

Articles of Incorporation: Carolyn reviewed the recommendation from Fred (Fritz) Milligan that our Association incorporate; reasons and advantages for doing so, and costs related to incorporation and registration of our name. Per the meeting of April 5<sup>th</sup>, a motion was made by Lori Mann to change the status of the Huber Ridge Area Association from that of being unincorporated to becoming incorporated, to file Articles of Incorporation with the Secretary of State for a fee of \$125.00, to register the name "Huber Ridge Area Association" with the Secretary of State for a fee of \$50 with the additional fee to renew this at \$25 per year, and to pay Atty. Fred Milligan the amount of \$125.00 for his services. Motion was seconded to approve, and **motion carried**.

Update and handouts were given on questions regarding the curfew and fence height regulations.

#### **New business:**

The Block Watch training will be held from 5-7 p.m. prior to the next HRAA general meeting on June 7<sup>th</sup>. Doug Murphy has sent out notices to all block watch members with a request to respond before May 18<sup>th</sup>. Pizza, salad and drinks will be provided.

Carolyn discussed the possibility of having a professional landscaper give us ideas for the entrances to Huber Ridge off of 161 and Buenos Aires, and Westerville Road. We can get bids from professionals, have plans developed by them, but do the work ourselves. Consensus from the attendees was that we further investigate this and get estimates at this time.
