- c. New logo: Attendees were shown the design that the Executive Committee preferred that was developed by Gwen Bair. We have requested additional adjustments be made, and will be receiving those new designs shortly.

New Business:

- a. Newsletter delivery team: Carolyn introduced Eric Cordray as the new *Herald* delivery distribution lead, with June Riggs and Jean Welch as members of the team.
- b. Concerts in the Park: Jim Welch distributed a handout entitled "2013 Concerts in Ridgewood Park, Proposal for HRAA Sponsorship." Attendees were given the opportunity to review the document, and a motion to approve the proposal for the HRAA, Inc. to be the primary sponsor of the concerts in the parks was made by Anna Grant.

Questions/concerns were voiced and addressed regarding liability, definition of sponsorship, type of music that would be offered, hours and length of concerts, concessions and other items which were of concern to attendees.

After discussion, Anna Grant's motion to approve HRAA, Inc. as the primary sponsor of the concerts was seconded and put to a vote. Voting was done by having those who approved of the motion stand up. After a count was made, those who were opposed to the motion then stood up.

Motion carried by a vote of 16 in favor, to 1 opposed.

2013 Concerts in Ridgewood Park Proposal for HRAA Sponsorship

OVERVIEW

A committee of Huber Ridge residents and Blendon Township officials have been meeting with a goal toward arranging for a small series of concerts to take place in Ridgewood Park this summer. The committee is in the process of developing sponsorship relationships with local merchants for the purpose of underwriting costs for the concert series in exchange for promotional opportunities at the concert events.

PARTNERSHIP AND LIABILITY

The committee envisions that a Blendon Township and HRAA Partnership in this venture is the cornerstone of success for the event. Blendon Township investigated the issue of partnering with the neighborhood association as well as event liability with the township attorney Bruce E. Bailey for this sort of event. His recommendation is as follows:

"The Township enjoys immunity in the operation of its parks from two sources, the recreational immunity statute (ORC section 1533.181) and the political subdivision tort liability statues (ORC Chapter 2744). Both come into play if the park or in this case the park event is open to indiscriminately to the public without charge or the requirement of the payment of a fee.

Accordingly for you event to benefit from these immunity provisions I recommend that the events be hosted by the Township; be in the Township park; be free; and be sponsored by the applicable civic association."

By Blendon Township taking on the role of "host" and the HRAA being the primary organizing sponsor of the event allows the event to fall under the ORC sections 1533.181 and 2744. The trustees are enthusiastic proponents for this event, however priorities in organizing new initatives and committees as a direct result of the recent election of the JEDZ and Home Rule leaves the township to look toward residents to take the lead in making this idea a reality. Growing interested within the Huber Ridge community led to the formation of the committee as well as the formation of the partnership with Blendon Township.

SPONSORSHIP

The committee envisions that sponsorship by the HRAA would involve the following:
