We also talked about doing a phone tree for Block Watch reps when they observe something that doesn't need to reach the police notification level but rather just keeping other reps up on things going on.

That being said, Pam Clegg sent two e-mails to Chief Belford requesting increased patrols in a potential problem area and that's the kind of thing we should be doing and I want to commend her on her actions and vigilance.
