# Block Watch:

#### Block Watch:

Attached is the October 2013 Block Watch Report. We have two new reps this month, and I'll be sending them the program materials this week after I get more printed. Welcome to Shannon Chandler (5959 Balboa Road, 614-256-9869) and Lynn White (5615 Spohn Drive, 614-849-8321).

With the October 20 murder of Jane Juergens by a 16-year-old from a group home and charged with her death, I've thought many times "could Block Watch have done more to prevent her killing?" The answer is no. The issues at this group home on Copenhagen (and at another on Santiago operated in the same neglectful manner by Consumer Support Services) are well documented. The Block Watch Reps and the neighbors around those homes have received no assistance from Franklin County Children's Services. Both FCCS and CSS should, in my opinion, be held accountable in a court of law. These groups took county tax payers' funds for years and did little for the kids under their care. The terms fraud, waste, and abuse are applicable to those in charge of these "human puppy mills," and the citizens of this county deserve better. The kids in their care deserve better!

To that end, there is a group of community members who have been meeting since this happened and are trying to resolve the issue of these under-supervised and poorly-regulated group homes. Their efforts are to determine how these facilities should be run better and make recommendations for well managed group homes. We also intend to assure that those responsible for any criminal wrongdoing under current law and ethical lapses are held accountable by law enforcement and accrediting organizations. Where beneficial to solving the root cause problems, we will seek to have the laws changed in order to provide more oversight of these homes at the local level, while maintaining the need for the help from the community these kids deserve. Our efforts will give the trustees and our state-elected officials the energy they need to have these laws changed. We are fighting against an under-regulated and under-supervised industry whose estimated income from the State of Ohio through agencies like FCCS is over \$100,000,000 per year. That industry will not back down without a fight, and we need to keep the public aware of our efforts.

Lastly, I wish to inform the HRAA that for several reasons I find it necessary to step down as the Block Watch Coordinator soon. I've served for almost two years, and while interest in the program is growing, I will have to step aside for new leadership. I envision a team of Block Watch Reps rotating through in leadership positions every 6 months or so, and I can assist for the next few months until that is set up, if warranted. Some of the things that I have been doing are being worked by other reps and we just need two more reps to have a successful transition. No more than 1 hour per month to make contact via e-mail or phone to other reps.
